No date had been fixed for the Cicero march, but the tactic of multiple marches, which stretched the police to the limit, served equally well. About one thousand people took part in Sunday's triple protest. Although they walked into the usual barrage of bricks and bottles, the most serious violence occurred away from the marches, in Marquette Park, where Nazi and Klan orators encouraged a crowd of three thousand whites to go on the rampage.⁴⁴

The *Chicago Tribune* fulminated against the CFM's tactics. "Causing violence to achieve political ends is criminal syndicalism," it asserted. "If the marchers keep up their sabotage it will be time to indict the whole lot of them." The *Tribune's* angry editorials provided one yardstick of the marches' effectiveness. Provocative or not, they placed Daley in a quandary. With the police attempting to protect the marchers, his administration was receiving the blame for what most whites perceived as a black invasion. And with the autumn elections approaching, the Republicans stood to benefit from the "backlash." "Every time we march," Bevel exulted, "Daley loses 10,000 votes—
